Games will be played at the WS Recreation Center, 1500 Walker on Tuesday, Wednesday or Thursday at 6:00 or 7:00 pm beginning June 18 and ending July 18. Practices begin week of June 3; times determined by coaches.

Volunteer Coaches Needed: – The league will only work if parents act as coaches/managers. Please sign up below. A coaches' meeting is set for Tuesday, May 28, 6:30 pm at the Recreation Center. Teams will be selected based on Skill Assessment (see above) in order to make them as equal as possible.
